### DEVELOPMENTAL DISABILITIES SERVICE COORDINATION, WESTERN

#### Description:

ELIGIBILITY DETERMINATION FOR SPECIALIZED SERVICES; AUTHORIZING SERVICE DELIVERY FOR ELIGIBLE PERSONS; ENSURING THAT SERVICES ARE AVAILABLE, ACCESSIBLE AND COORDINATED. ASSURING THAT A TEAM PROCESS, INCLUDING THE INDIVIDUAL AND THE FAMILY, IS USED TO ASSESS AND DEVELOP AN INDIVIDUAL PROGRAM PLAN FOR SERVICES; PROVIDING INFORMATION AND REFERRAL SERVICES TO PERSONS WITH DEVELOPMENTAL DISABILITIES AND THEIR FAMILIES; AND COORDINATED LOCAL SERVICE NETWORKS. \*THIS OFFICE ALSO HANDLES APS AND AGED & DISABLED MEDICAID WAIVER SERVICES. FEES ARE DETERMINED BY STATE.
